Please read the following for important NJ State Election Laws: Proceeds will benefit the Election Fund of Dave Rible, New Jersey law prohibits entities operating in certain regulated industries (casinos, financial institutions, insurance companies, utilities) from contributing. Election Law allows contributions with a limit of \$2,600 per election from individuals and corporations and \$8,200 per entity. A partner's total contribution, through the partnership and personally, can not exceed the \$2,600 per election limit. Contributions are not deductible for income tax purposes.
